SUNDAY USE OF FACILITIES

STUDENT SUNDAY ACTIVITIES

The Board granted permission for MVHS DECA students to travel to the International DECA Competition in Anaheim, California on April 23-28, 2013 and for MVHS art students to travel to Nashville, Tennessee on April 27-28, 2013.

GROUP INSURANCE CONSULTING SERVICES

The Board entered into a one-year agreement with Brown & Brown of Indiana as a group insurance consulting firm for a fee not to exceed \$24,000 effective April 1, 2013 as recommended.

AGREEMENT FOR SOCIAL WORKER SERVICES

The Board entered into an agreement with Youth First to continue programs and services provided by Youth First social workers for the remainder of the 2012-13 school year as recommended.

REFINANCING PENSION BONDS RESOLUTION

The Board adopted a supplemental bond resolution to refinance pension bonds through the Indiana Bond Bank to provide substantial savings to the school district at no cost.
