**PAYMENT OF ADDITIONAL DAYS FOR 2014-15**

The Board authorized the payment of normal daily wages for each applicable employee in the following employee groups for the unworked days that would have been included in a normal 2014-15 school calendar:

- Food Service managers and regular workers: paid for an additional three (3) days
- School Bus Attendants: paid for an additional three (3) days
- School Secretaries: paid for an additional two (2) days
- Teacher Assistants: paid for an additional two (2) days

Other school employees not listed in the above groups will also be paid for the entire school year, including school days not made up, by virtue of their employment contracts or existing benefit packets which already allow for that payment.

### **NON-RESIDENT STUDENT TRANSFER PARAMETERS**

The Board designated, for the 2015-16 school year, total student capacity, including resident and non-resident student transfers, to be 240 students per grade level and January 20, 2016 as the date by which requests to transfer into the school corporation must be received.
