The Board of School Trustees of the Metropolitan School District of Mt. Vernon, Indiana met in a regular meeting on Monday, March 7, 2022 at 5:45 p.m. at Mt. Vernon Senior High School, 700 Harriett Street, Mt. Vernon, Indiana

Present were Board members Mark Isaac, Beth McFadin Higgins, Greg Oeth, Joe Rutledge, and Kathy Weinzapfel; administrators Loren Evans, Director of Business and Technology; Bo Harris, Program Director, and Matt Thompson, Superintendent of Schools; and Junenna Young representing the NEA.

The meeting was called to order by Board Vice President Mark Isaac and the Pledge of Allegiance was given.

The Board:

8. appointed Vicki Rueger as a replacement for Dan Koch on the Alexandrian Public Library Board for the remainder of his four-year term effective March 8, 2022 through December 31, 2023 as recommended. (McFadin Higgins-Rutledge)
